

PALMETTO ANIMAL REIKI, LLC
SERVICES AGREEMENT

This Service Agreement is between Palmetto Animal Reiki, LLC (“Palmetto”) and [CLIENT] (“Client”).

WHEREAS, Palmetto agrees to provide services to Client on the terms and conditions set out in this Agreement.

Therefore, for sufficient consideration, both parties agree to the following terms. Any additional terms that alter this Agreement must be in writing and agreed to by both parties.

1. SCOPE, SERVICES, RELATIONSHIP OF PARTIES, OTHER TERMS

- 1.1. Scope of Project and Additional Fees for All Expansions. (“Services”). A one hour meeting will cover a Reiki energy session, as well as intuitive counseling.
- 1.2. Compensation/Payment Schedule. Client agrees to pay Palmetto **\$100** per one hour session. Payment shall be made no later than 30 days within date of services. Failure to make timely payment shall incur late fee costs of 5% each 30 days payment is late.
- 1.3. Independent Contractor. Palmetto is an independent contractor of Client.

2. RELEASE OF LIABILITY, NO GUARANTEE

- 2.1. **Release from liability.** Client hereby agrees, on behalf of himself or herself, and his or her heirs and personal representatives, to fully and forever discharge and release Palmetto, their affiliates, and their respective partners, agents, operators, managers, employees, and property owners (“Released Parties”) from any and all claims Client may have or hereinafter have for any injury, temporary or permanent disability, death, damages, liabilities, expenses, costs, and/or causes of action, now known or hereinafter known in any jurisdiction in the world, attributable or relating in any manner to Client’s entry upon the Property and participation in the Services, whether caused by the negligence of the Released Parties or by any other reason. Client acknowledges and agrees that this Release is intended to be, and is, a complete release of any responsibility of the Released Parties for any and all personal injuries, temporary or permanent disability, death, and/or other damage sustained by the Client while on the Property or in any way related to the Services activities.
- 2.2. **No Guarantee of results.** Client understands that Palmetto does not guarantee results with in any way with any animal or person. Client assumes all risk of undertaking Palmetto’s services.
- 2.3. **Assumption of risk and waiver of liability related to COVID-19/Coronavirus.** The World Health Organization (WHO) has declared the Coronavirus/COVID-19 a worldwide pandemic which is highly contagious and believed to be spread mainly from person-to-person contact. As a result of recommended social distancing, Palmetto has put in place preventative measures to reduce the spread of COVID-19 during in-person Reiki sessions. However, Palmetto cannot guarantee that the client will not become infected with COVID-19. By signing this agreement, the client acknowledges the contagious nature of COVID-19 and voluntarily assumes the risk to him or herself.

3. MISCELLANEOUS PROVISIONS

- 3.1. Due to the extreme unpredictability of animals and people, Palmetto cannot accept responsibility for any mishaps of any extraordinary or unusual nature (i.e. biting, furniture damage, accidental death, etc.) or any complications in administering medications to the animal(s). Palmetto cannot be liable for injury, disappearance, death, or fines of pets with access to the outdoors. Additionally, Palmetto is not responsible for any harm that your pet may cause to another pet or property during a session or while with Palmetto. Client is responsible for any damage or injury by animal or person to Palmetto’s property.
- 3.2. Reiki Release. Client assumes all responsibility for actions taken following treatment.
- 3.3. All pets must be currently vaccinated and flea free. Client will be responsible for all medical expenses and damages resulting from an injury by the pet or exposure of any diseases or ailments to Palmetto. Client agrees to indemnify and hold harmless Palmetto in the event of a claim by any person injured by the pet.
- 3.4. Palmetto agrees to provide the services stated in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the Client expressly waives and relinquishes any and all claims against Palmetto except those arising from negligence or willful misconduct the part of the Palmetto
- 3.5. Attorney’s Fees. If either party retains an attorney to enforce or defend their rights under this agreement, the prevailing party in such an action shall receive payment for reasonable attorney’s fees from the other party.
- 3.6. Governing Law. The terms of this Agreement shall be interpreted and governed by the State of South Carolina.
- 3.7. Client understands that Reiki is a simple, gentle, hands-on energy technique. The client understands that Palmetto does not diagnose conditions nor do they prescribe or perform medical treatment, prescribe substances, nor interfere with the treatment of a licensed medical professional. Client understands that Reiki does not take the place of medical care.
